THE DISTRIBUTION AGENT'S FOURTH STATUS REPORT

JND Legal Administration ("JND"), the Court-appointed Distribution Agent in the abovecaptioned matter, respectfully submits this Status Report pursuant to this Court's Order entered March 4, 2021 (the "Order", ECF No. 89) and the Plan of Distribution approved by the Court on May 26, 2021 (the "Plan", ECF No. 95). By the Order, this Court appointed JND as the Distribution Agent for the collections in this action (the "Distribution Fund"), to oversee the administration and distribution of the Distribution Fund in coordination with the Securities and Exchange Commission's ("SEC") counsel of record. Pursuant to paragraph 4(h) of the Order, the Distribution Agent is required to file with the Court or provide to the SEC's counsel of record to file with the Court, its first status report within forty-five days of Court-approval of the Plan, and additional reports within thirty days after the end of every quarter. This Status Report covers the period from January 1, 2022, through March 31, 2022.

Tasks Performed by the Distribution Agent Since the Third Status Report

Since the third status report, JND has performed the following tasks in connection with its role as the SEC-appointed Distribution Agent:

- Completed evaluation of claims and sent Determination Notices to Potential Claimants¹ setting forth the determination of the eligibility of their claim (eligible, ineligible, partially deficient or wholly deficient);
- Reviewed physical and electronic responses to the Determination Notices received from claimants; and
- Prepared and sent Final Determination Notices to the claimants who responded to Determination Notices.²

Anticipated Next Steps

JND will continue to execute the Plan of Distribution, including:

- Working with the Tax Administrator and the SEC staff to determine the Net Available Distribution Fund;
- Establishing the Escrow and Deposit Accounts;
- Determining Eligible Claimants' Distribution Payment in accordance with the Plan of Allocation;
- Performing all activities necessary to prepare for the distribution of the Distribution Fund in accordance with the Plan, including compiling the Payee List and drafting a declaration in support of an SEC motion to disburse funds;

² These 28 Final Determination Notices were mailed after the end of the quarter, but before the execution of this Status Report.

- Upon receipt of funds from the Commission staff, commence issuing Distribution Payments; and
- Filing a Fifth Status Report along with the first quarterly accounting report within 30 days of June 30, 2022.
